("HTTA") for inclusion in the Hope & Healing Juried Art Show (the "Event"), and intending to be legally bound, agrees as follows:</p>		
<p>1. Permission to Use Artwork, Photos, Images and Likenesses. The Artwork entry described above is an original work of authorship personally created by the Student, is not copied from, nor does it include any other person's copyrighted work and it is entitled to copyright protection. The undersigned grants to HTTA the right to publicly display the Artwork at and during the Event, and in connection with the Event and any adjunct thereto. The undersigned acknowledges and agrees that the final decision regarding the suitability of any artwork entry to be displayed at the Event shall be made by HTTA within its sole and absolute discretion. The undersigned consents to and grants to HTTA and its successors, assigns, transferees, licensees, sublicensees, anyone authorized by HTTA (including operators of any third party websites) and any other third party, including hospitals and healthcare facilities and their successors, assigns, transferees, licensees, and sublicensees ("Third Parties") the perpetual, worldwide, absolute right and privilege to reproduce the Artwork and display, use, re-use, publish, re-publish, syndicate, copyright and license to others any reproduction or photograph, image, likeness, film, videos and pictures of the Artwork, and/or materials in which the Artwork may appear or be included, and also in conjunction with the Artwork, the Student's name, above Student Information, image, voice, likeness, photographs, film, videos, pictures, and/or materials in which the Student may appear or be included, and/or statements made by the Student, in whole or in part, or composite or distorted in character or form, without restrictions as to changes or alterations, and of any reproductions thereof in color or otherwise, for any use or purpose whatsoever, including, but not by way of limitation, the sale, publication, display and exhibition thereof in products, editorial, promotion, advertising, or otherwise and in any and all media now or hereafter known, including, but not limited to, print, Internet, television, optical, digital, electronic, CD-ROM, and online use, without any further compensation. The undersigned agrees that the photographs, film, videos, pictures, and/or materials and negatives thereof, shall constitute HTTA's sole property, with full right of disposition in any manner whatsoever. The undersigned agrees to indemnify, hold harmless and defend HTTA from and against any and all claims, costs and expenses of any nature whatsoever, including, but not limited to, claims for misappropriation, copyright infringement, invasion of privacy, or any similar claims arising out of or in any way related to the Artwork.</p>		
<p>2. Transfer of Ownership. The undersigned hereby agrees to transfer to HTTA and Third Parties all rights, title, interests, and copyrights to the Artwork created by the undersigned Student, and the undersigned agrees to execute any documents that may be necessary to transfer such rights, without further compensation. HTTA shall exercise commercially reasonable best efforts to transfer all rights, title, interests, and copyrights in the Artwork to a Third Party hospital or other healthcare provider for display of the Artwork in locations visible to patients and/or their caregivers and/or families. The undersigned hereby assigns its copyright in the Artwork to HTTA and any Third Parties to the fullest extent permitted by law for the duration of the copyright and any extensions thereof. The undersigned hereby appoints HTTA and any Third Parties as attorney-in-fact to sign any documents necessary to transfer and assign the undersigned Student's copyright in the Artwork to HTTA and any Third Parties, and further agrees to sign any other documents reasonably necessary to transfer and assign said copyright to HTTA or any Third Parties. The undersigned agrees that HTTA (and any Third Party, as applicable) shall be the owner of the copyright in Artwork throughout the world.</p>
